We just announced that Broadcom has entered into an agreement to acquire VMware, a leading innovator in enterprise software that pioneered virtualization technology. This transaction will add significant scale to our software business and continues our track record of acquiring established, mission-critical platforms.

VMware has long been recognized for its enterprise software leadership, and through this transaction we will provide customers worldwide with the next generation of infrastructure software.
